

Peter Thorp addressed the Council as a representative of the shop keepers in the village, raising concerns over the Yellow Line Consultation which is taking place and the detrimental impact that this will have, on their businesses. He has spoken with Mr Hodgeson, Highways Division, who is unable to explain the reason why this proposal is being considered. Parish Council Members advised all proprietors who feel that this will impact upon their business to write and voice their objections. Cllr Wood informed him that there had previously been an informal agreement with the landlord of The Bull Public House, allowing shop keepers to use his car park, to free up parking spaces for customers. Cllr Duff agreed to speak with the landlord and check that this was still correct and inform local shop keepers.
